Penalties

Late bookers ⁵ (< 5 working days)	€ 550,- processing fee
Commercial events without permission	€ 3.500,- per incident and day
Punitive damages of as much as the maximum amount of the damages causes, irrespective of penalty fees	

All above mentioned tariffs and fees are exclusive of 20% value added tax. Billing units: 24 hours

¹ All usage is under certain conditions in order to guarantee the sustainable treatment of nature and its resources. The conditions are part of the user contract, which must be concluded with ÖBf in all cases. Please note that events require timely approval by authorities. In national parks special rules are applicable. Bad weather is not a reason for recourse. WILD.MEDIA Nature Guidelines for sustainable site usage apply. This tariff list is valid from January 2013.

² With participants we mean all persons involved in the event who are on site (organizers, helpers, participants, visitors, spectators).

³ Transit fees apply if sites for events or advertising only can be reached by crossing ÖBf sites, or the character of the event requires transit via ÖBf sites (e.g. rallies, bike races and the like).

⁴ Attendance by ÖBf staff if required according to contract.

⁵ Late bookers: registration of use less than 5 working days prior to the start of usage or any set up required.
